

## ROAD ORDER

Sept. 5, 1876

## CHANGE IN ROAD

At a meeting of the Committee appointed by the Board of County Commissioners of said County, held August 22nd, 1876, the report of the Committee appointed by us at our last session to examine the road hereinafter named have reported that they met at the time and place designated in our order of appointment and examined the highway proposed to be changed viz: Commencing where said road strikes the South line of the Northeast 1/4 of Section 11, Town 29, Range 23, thence West on said 1/4 section line to the center of said section, thence North on the ~~SE~~ section line or as near as practicable thereto thence along the Western edge of the March to the intersection of a town road from Little Canada thence Westwards along said Town Road to its intersection with the line of said Saint Paul, Bass Lake and Mounds View Road in said Ramsey County and recommended that the prayer of the petitioners for said highway be granted; it is therefore ordered and determined that the prayer of said petition be granted; and that a highway be and is hereby changed according to the description above given, which is hereby declared to be a public highway and the Auditor is hereby directed to notify the Supervisors of the several towns through which such road is located and changed that they cause so much of said highway as lies in their respective towns to be opened without delay. We have assessed the damages sustained by the following persons by reason of the laying out, etc. of such highway across their lands as follows:

The petition of citizens of Rose Town for a road "Commencing from where said road strikes the south line of the N. E.  $\frac{1}{4}$  of Section 11 Town 29 Range 23, thence west on said  $\frac{1}{4}$  section line to the center of said section 11 thence north on  $\frac{1}{4}$  section line or as near as practicable thereto along the western edge of the marsh to the intersection of a town road from Little Canada westward, thence along said town road to its intersection with the line of said St. Paul, Bass Lake and Mounds View road, the name of the road referred to herein and desired to be changed. Referred to the Committee on Roads and Bridges.

The undersigned Committee appointed by you to examine the proposed change of a highway as stated in the petition referred to in your order of appointment made on the 6th day of June 1876, would respectfully report that we met at the time and place designated in your said order and proceeded to examine the highway proposed to be changed viz: Commencing where said road strikes the South line of the Northeast quarter of Sec. 11, Town 29, Range 23, thence North on quarter section line or as near as practicable therefo, thence along the Western edge of the march to the intersection of a town road from Little Canada, thence Westwards along said town road to its intersection with the line of said Saint Paul Bass Lake and Mounds View road to said Ramsey County and do hereby recommend that the prayer of the said petitioners be granted.
