That after said examination said committee did submit to said Board at its next session thereafter, to-wit: on the 15 day of July, 1940 its report thereof setting forth the course and distances of said portion of said road, and recommending the granting of said petition; which report is on file in the office of said County Auditor and is hereby referred to as a part Rereof
