

Petition for change of County Road

Manamin Road or Co. Rd. #64-2

Nov. 29, 1902

To the Board of County Commissioners of the County of Ramsey, Minnesota:

The undersigned freeholders of the County of Ramsey residing therein petition your Honorable Board for the change of a highway, running into more than one town of said County, and not within the limits of any incorporated city, and known as "Manamin Road", and your petitioners pray that you will vacated all that portion of said above named highway which runs as follows:

Beginning at the center of section 14, township 30, range 23 and running thence southwesterly through the southwest quarter of said section 14 to a point on the section line between sections 14 and 15. Town and Range aforesaid, 696 feet north of the southwest corner of said section 14. And now connected with other roads as follows: Town road at the center of section 14, Town 30, Range 23. And Lexington Avenue at a point 696 feet north of the southwest corner of section 14, Township 30, Range 23.

So that the same when changed will run as follows: Beginning at a Town Road, at the southeast corner of the southwest quarter of the northwest quarter of Section 14, Township 30, Range 23 and running thence west on the south line of the aforesaid southwest quarter of the northwest quarter of section 14 to Lexington Avenue at the quarter section corner between sections 14 and 15 Town and Range aforesaid, and to be connected with other roads as follows: Town road at the southeast corner of the southwest quarter of the northwest quarter of section 14, Town 30, Range 23. And Lexington Avenue at the quarter section corner between 14 and 15, Town 30, Range 23.

The names of the owners of the lands as far as known, through which the same now passes, are: Bartholomew O'Malley, School District No. 4, Charles Koth. And the names of the owners of the lands, as far as known, through which the same may pass when changed, are Bartholomew O'Malley.

And your petitioners pray that you will proceed to change said road, and cause the same to be opened according to law. Dated at St. Paul this 29th day of November, 1902.
