Town and Range aforesaid, 556 feet north of the southwest corner of said section 14. And now connected with other reads as follows: Town road at the center of section 24, Ross 30, Range 23. And Lexington Avenue at a point 696 feet north of the southwest corner of acciden 14, Township 30, Range 23.
