Kipp and C.B. Mersseran to which they avowed \$1.00 each a warrant to-wit: drawn for the same S. & O. Kipp, damages for road layed in section one, \$1.00

ROSE TOWNSHIP

State of Minnesota, County of Ramsey, Town of Rose: SS.

Whereas upon the petition of six legal voters, owning real estate or occupying real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within one mile of the road proposed in said petition to be laid out, which said petition was duly filed with Town Clerk, copies of said petition having been first duly posted up in three of the most public places in said town at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit, which said proposed new road is set forth and described in said petition as follows:

Beginning at the Northeast corner of the Southeast  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of section 1, township 29, range 23, running west on  $\frac{1}{4}$   $\frac{1}{4}$  line 3960 feet more or less to the Northwest corner of the Southeast  $\frac{1}{4}$  of the Northwest  $\frac{1}{4}$  of section 1, township 29, range 23.

And whereas, upon receiving said petition, we did, within thirty days after make out a notice and fix within a time and place at which we should meet and decide upon application, to-wit: the 13th day of December, 1897, at the house of E.A. Boyd, in section 1, causing copies of such notice to be posted in three public places in said town, at least ten days previous to such meeting and having met at such time and place of hearing, to be given to all occupants of the land through which highway might pass by serving the same personally, or by copy left at the usual place of abode, of each of said occupants, proof of which was shown by affidavit we proceeded to examine personally such highway and heard any and all reasons for or against the laying out the same, and being of the opinion that such laying out was necessary and proper that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out said road. It is therefore ordered and determined that a road be, and the same is hereby laid out and established according to the description aforesaid and is hereby declared to be a public highway four rods wide, the said description above given being the center of said road, given under our hands this 13th day of Dec. 1897.
