## COUNTY COMMISSIONERS' ROAD ORDER

STATE OF MINNESOTA )  
 County of Ramsey ) SS.

At a meeting of the Board of County Commissioners of said County, held December 7th 1886, a copy of the report of the committee appointed by us at our last session to examine the road hereinafter named, having been duly returned, by which said report it appears that the said committee met at the time and place designated in our order of appointment and examined the highway proposed to be changed west beginning at a point on the St. Paul Lake Phalen and White Bear Road running through the southwest quarter (S.W. 1/4) of the southwest (S.W. 1/4) quarter of section Fifteen (15) Town Twenty-nine (29) Range Twenty-two (22) West, and continue said St. Paul, Lake Phalen and White Bear Road commencing at the southwest corner of said section Fifteen (15) thence due north to the quarter section line of said section Fifteen (15) thence east on said quarter section line to the St. Paul Lake Phalen and White Bear Road near the center of said section Fifteen (15).

And recommended that the prayer of the petitioners for the change of said highway be granted; and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the change of said highway and that the change of said road would be of sufficient advantage to the County to warrant the paying of the damages hereinafter assessed, we do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby changed according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which such highway is changed, that they cause so much of said highway as lies in their respective towns to be opened without delay.

We have assessed the damages sustained by reason of the changing and laying out of said road to the lands over which the same passes and to the owners thereof, as follows:

Wm. Durson, section 14, Owners in 14 and 16 1/2 runs over Town Road. The benefits are equal to the damages.

The undersigned freeholders of the County of Ramsey hereby petition your Honorable Board for the change of a highway, running into more than one Town of said County, and not within the limits of any incorporated City, and described as follows:

Vacate that portion of the St. Paul Lake Phalen and White Deer Road running through the southeast quarter (S.W. 1/4) of the southeast quarter (S.W. 1/4) of section Fifteen (15) Town Twenty-nine (29) Range Twenty-two (22) west, and continue said St. Paul Lake Phalen and White Deer Road commencing at the southwest corner of said section Fifteen (15) thence due north to the quarter section line of said section Fifteen. Thence east on said quarter section line (as near as practicable) to the St. Paul Lake Phalen and White Deer Road near the center of said section Fifteen (15).

The name of the course of the lands, as far as known, through which the same may pass, are:

William Denson and over a Town Road, the benefits are equal to the damages.

And your petitioners pray that you will proceed to change said road and cause the same to be changed according to law.
