Whereas, upon the petition of six legal voters owning real estate or occupying real estate under the homestead or preemption law of the United States or under contract from the State of Minnesota within one mile of the road proposed in said petition to be laid out, copies of said petition having been first duly posted up in three of the most public places of said town at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit which said proposed new road is set forth and described in said petition, as follows:

Beginning at the Northwest Corner of Section 20, Town 29, Range 23 and running thence East on the North line of said Section till it intersects the road known as the St. Paul and Minneapolis Road via Lake Como. And whereas upon receiving said petition we did within thirty days make out a notice and fix therein a time and place at which we would meet and decide upon said application, to-wit: on the Fifteenth day of September A.D. 1884 at the house of Mary Bohan, causing copies of such notice to be posted in three of the most public places of said town at least ten days previous to such meeting and having met at such time and place as above named in such notice and, being satisfied that the applicant had at least ten days previous to said time caused said notices of time and place of hearing to be given to all the occupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown to us by affidavit we proceeded to examine personally such highway and hear any and all reasons for or against laying out the same, and being of the opinion that such laying out was necessary and proper and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out said road, the description of which as so laid out is as follows:

Beginning at the Northwest Corner of Section 20, Town 29, Range 23, thence East on North line of Section 20 till it intersects the road known as the St. Paul and Minneapolis Road via Lake Como. It is therefore ordered and determined that a road be and the same is hereby laid out and established according to the description last aforesaid and it is declared to be a public highway four rods wide the said description above given being the centre of said road.

Given under our hands this the 15th day of September A.D. 1884.
