Thence East on Section line between Sections 8 and 9, 3 and 10 From thence to the center of Section 3 thence to the 1 post between Sections 2 and 3 Thence Southeast along the bank between Tamarae Marsh and Turtle Lake, thence East on Section line to the corner of Sections 1 and 2. It and 12 to the center of the Columbia Road in Mounds View Township, Ramsey County, to be known as the extension of the St. Paul, Lake Josephine and Mounds View Road and recommended that the prayer of the petitioners for said highway be granted; it is therefore ordered and determined that the prayer of said petition be granted; and that a highway be and is hereby located according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Empersion of the several towns through which such road is located that they cause so much of said highway as lies in their respective towns to be opened without delay.
