

CO. COMM. RD. ORDER

At a meeting of the Board of County Commissioners of said County, held September 5th, 1876, the report of the committee appointed by us at our last session to examine the road hereinafter named, have reported that they met at the time and place designated in our order of appointment, and examined the highway proposed to be located viz: Beginning at the $\frac{1}{4}$ post between Sections 15 and 22 Town 30 Range 23, Town of Mounds View, at the old Manomin Road Thence West on the Section line on said Manomin Road to the corner of Sections 15 and 16, 21 and 22, of said Town and Range; Thence West on Section line on the Manomin Road to the $\frac{1}{4}$ Post between Sections 16 and 21, Thence North on center line of Sections 16 and 9 to Section 4. Thence East on Section line between Sections 4 and 9, 3 and 10 From thence to the center of Section 3 thence to the $\frac{1}{4}$ post between Sections 2 and 3 Thence Southeast along the bank between Tamarac Marsh and Turtle Lake, thence East on Section line to the corner of Sections 1 and 2, 11 and 12 to the center of the Columbia Road in Mounds View Township, Ramsey County, to be known as the extension of the St. Paul, Lake Josephine and Mounds View Road and recommended that the prayer of the petitioners for said highway be granted; it is therefore ordered and determined that the prayer of said petition be granted; and that a highway be and is hereby located according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which such road is located that they cause so much of said highway as lies in their respective towns to be opened without delay. We have assessed the damages sustained by the following persons by reason of the laying out, etc., of such highway across their lands as follows:

TO THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF RAMSEY:

The undersigned committee appointed by you to examine the proposed location of a highway as stated in the petition referred to in your order of appointment made on the 28th day of April, 1876, would respectfully report that we met at the time and place designated in your said order, and proceeded to examine the highway proposed to be located viz: Beginning at the $\frac{1}{4}$ post between Sections 15 & 22, Town 30, Range 23, Town of Mounds View at the old Manomin Road thence West on Section line said Manomin Road to the corner of Sections 15, 16, 21 & 22 of said Town and Range thence West on Section line Manomin Road to the $\frac{1}{4}$ post between Sections 16 and 21; thence North on center line of Sections 16 and 9 to Section 4; thence East on Section line between Section 4 and 9, 3 and 10; thence to the center of Section 3 thence to the $\frac{1}{4}$ post between Sections 2 and 3; thence Southeast along the bank between Tamarac Marsh and Turtle Lake thence East on Section line to the corner of Sections 1 & 2, 11 & 12 to the Columbus Road in Mounds View Township, Ramsey County, and do hereby recommend that the prayer of the said petitioners be granted.

WHEREAS, on the fourth (4) day of March 1876, a petition signed by twenty-four (24) freeholders of said County was presented to us, praying for the location of a highway, beginning at the 1/4 post between Sections 15 and 22, Town 30, Range 23, Town of Mounds View at the old Manomin Road; thence West on Section line of said Manomin Road to the corner of Sections 15, 16, 21 and 22 of said Town and Range, thence West on Section line Manomin Road to the 1/4 post between Sections 16 and 21; thence North on center line of Sections 16 and 9 to Section 4; thence East on Section line between 4 and 9, 3 and 10 thence to the center of Section 3 thence to the 1/4 post between Sections 2 and 3 Thence Southeast along the bank between Tamarac Marsh and Turtle Lake; thence East on Section line to the corner of Sections 1 & 2, 11 and 12 to the center of the Columbus Road in Mounds View Township, Ramsey County, and being satisfied that at least thirty days' notice thereof has been given before this session of the Board, by posting up notices in three of the most public places in each of the towns through which such highway is proposed to be located we hereby appoint N. W. Johnson, Wm. Welch and Daniel Kelly members of this Board, a committee to examine such proposed road and hereby designate April the 25th 1876, at 11 o'clock A.M., at the house of John Doherty in the Town of Mounds View in said County as the time when and the place where such committee will meet for said purpose upon said route.
