

## FINAL ROAD ORDER OF TOWN BOARD

Sedalia Ave. or R-18

Whereas, upon the petition of sixteen (16) legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within three (3) miles of the road proposed in said petition to be established; which said petition was filed with the Town Clerk, who forthwith presented it to us for action thereon, and which said proposed new road is set forth and described in said petition as follows, viz: Beginning at the northwest corner of the east one-half (E.  $\frac{1}{2}$ ) of the Northeast quarter (N.E.  $\frac{1}{4}$ ) of Section 15, Township 29, Range 23, thence running south on the quarter quarter (1/4) section line to a point due east of the northeast corner of Block Thirteen (13) Midway Hills, rear of Como G.L. the west one-half (W.  $\frac{1}{2}$ ) of said road having been heretofore dedicated on the Plat of said Midway Hills rear of Como G.L. and a portion of east one-half (E.  $\frac{1}{2}$ ) having been dedicated by the Plat of Pothens Garden Hills.

And Whereas, Upon receiving said petition, we did, within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and act upon said petition, to-wit: On the 29th day of November, 1930, at Northern terminus of proposed road causing copies of such notice to be posted in three public places in said Town, at least ten days before such meeting; and having met at such time and place as above named in said notices and being satisfied that the petitioners had, at least ten days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land through which such road might pass, by serving the same personally upon each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such road, and heard all persons interested, and any and all reasons for or against the laying out and establishing of the same, and being of the opinion that such laying out and establishing was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out and establish said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so laid out and established is as follows, to-wit: Beginning at the Northwest corner of the east one-half (E.  $\frac{1}{2}$ ) of the Northeast quarter (NE  $\frac{1}{4}$ ) of Section 15, Township 29, Range 23; thence running south on the quarter quarter (1/4) section line to a point due east of the northeast corner of Block Thirteen (13) Midway Hills rear of Como G.L., the west one-half (W.  $\frac{1}{2}$ ) of said road having been heretofore dedicated on the Plat of said Midway Hills rear of Como G.L. and a portion of east one-half (E.  $\frac{1}{2}$ ) having been dedicated by the Plat of Pothens Garden Hills.

IT IS THEREFORE ORDERED AND DETERMINED; That a road be, and the same is hereby laid out and established according to the description last aforesaid, and the report and plat herewith accompanying which is hereby made a part of this Order, and it is declared to be a public road four rods wide, the said description above given being the center of said road.
