

PETITION FOR A CO. RD.

TO THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF RAMSEY, STATE OF MINNESOTA

The undersigned freeholders of the County of Ramsey hereby petition your Honorable Board for the opening of a highway, running into more than one Town of said County, and not within the limits of any incorporated City, and described as follows: Commencing on the section corners of Sections nine (9), ten (10), fifteen (15), and sixteen (16), thence North on Snelling Avenue to the point where said Snelling Avenue was vacated some years ago, thence following said part which was vacated as near as practicable, until reaching a point at which said Snelling Avenue crosses the Section line between Sections three (3) and four (4) Town 29, North Range 23, West, thence North on said Section line about three-quarters (3/4) of a mile to the quarter section corners of said sections 3 & 4, thence West on said quarter section line one-quarter of a mile, thence North of West until reaching a point on Township line between Rose and Mounds View Town, thence West on said Town line to one-half Section corner of Section four (4), in Rose and Section thirty-three (33) in Mounds View, thence North one hundred (100) feet.
