WHEREAS, Upon the petition of thirty-five (35) legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within three (3) miles of the road proposed in said petition to be established; which said petition was filed with the Town Clerk, who forthwith presented it to us for action thereon, and which said pro-posed new road is set forth and described in said petition as follows, vis: Beginning at a point in the north line of County Road *B* 658.67 feet east of the decree of Section 10 T. 29, R. 23, thence north to the east and west center line 656.68 feet east of the center of said Section, the herein described line being the center line of a 66 feet strip of land being 33 ft. in width on either side, and to be used for road.

AND WHEREAS, Upon receiving said petition, we did, within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and not upon said petition, to-wit: On the 29th day of September, 1934, at 2:00 P.M. at southern terminus of proposed new road, causing copies of such notice to be posted in three public places in said Town, at least ten days before such meeting; and having met at such time and place as above named in said metice; and being satisfied that the petitioners had, at least ten days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land through which such road might pass, by serving the same personally upon each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such road, and heard all persons interested, and any and all reasons for or against the laying out and establishment was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out and establish said road, and caused a survey thereof to be made ascording to the report and plat herewith accompanying, the description of which as so laid out and established is as follows, to-wit: Beginning at a point in the morth line of County Boad "B" 658.67 feet east of the t corner of Section 10 T. 29 R. 23, thence north to the east and west center line 656.65 feet east of the center of said Section, the herein described line being the center line of a 66 feet strip of land being 33 ft. in width on either side, and to be used for road.

IT IS THEREFORE ORDERED AND DETERMINED, That a road be, and the same is hereby laid out and established according to the description last aforesaid, and the report and plat herewith accompanying which is hereby made a part of this Order, and it is declared to be a public rend four (4) rods wide, the said description above given being the center of said road.
