whereas, upon the petition of six legal voters owning real estate within one mile of the road proposed in said petition to be laid out copies of said petition having been first duly posted up in three of the most public places of said Town at least twenty days before any action was had in relation thereto, proof of which posting was shown to us by affidavit which said proposed new road is set forth and described in said petition as follows, vis: Beginning at SW cox. of Sec. 4, Town 29, Range 23, where said line intersects Smelling Avenue; thence Borth on said Sec. line one mile to the cors. of Secs. 3 and 4, Rose Town and 33 Mounds View Town;

and whereas, Upon receiving said petition we did within thirty days thereafter make out a notice and fix therein a time and place at which we would meet and decide upon said application to-wit: On the 3rd day of august A.D. 1855 at Robertson Lake at three o'clock in the aftermoon causing copies of such Sotice to be posted up in three of the most public places in said Town at least ten days previous to such time of meeting and having met at such time and place as above named in such Rotice and being satisfied that the applicant had at least ten days previous to said time caused said Sotices of time and place of hearing to be given to all the occupants of the lands through which such highway might pass by serving the same personally or by copy left at the usual place of abode of each of said occupants proof of which was shown to us by affidavit, we proceeded to examine personally such highway and hear any and all reasons for or against laying out the same and being of the opinion that such laying out was necessary and proper and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out said road the description of which as so laid out is as follows, to-wit: Beginning at 3W cor. of Sec. 4, Town 29, Range 23, where said line intersects Snelling Avenue, themse Sorth on said Sec. line to lake about ninety rods thence around East and of lake to the Sec. line thence Borth on said Sec. line to the cors. of Secs. 3 and 4, Rose Town and 33 and 34 Mounds View Town. It is therefore ordered and determined that a road be and the same is hereby laid out and established according to the description last aforesid and it is hereby declared to be a public highway four rods wide. The said description above given being the center of said road.
