

PETITION FOR CHANGE OR VACATION OF COUNTY ROAD

TO THE COUNTY BOARD OF RAMSEY COUNTY, MINNESOTA:

The undersigned freeholders of the County of Ramsey residing therein petition your Honorable Board for the change of a highway, running into more than one town of said County, and not within the limits of any incorporated City, and described as follows:

Beginning at the shore of White Bear Lake on the East line of Section 24, Township 30, Range 22,

And running thence south along the East line of Sections 24-25 and 36, Township 30, Range 22; also along the east line of Sections 1-12-13-24-25 and 36, Township 29, Range 22, and the east line of Sections 1 and 12, Township 28, Range 22, to a point 1299 feet south of the $\frac{1}{4}$ corner on the east line of Section 12; thence along the present traveled road to a point on the east line of Section 12, Township 28, Range 22, distant 214 feet north of the southeast corner of said Section 12; thence south along the east line of Sections 12 & 13, T. 28, R. 22 and terminating at the $\frac{1}{4}$ corner on the east line of Section 13, Township 28, Range 22.

And your petitioners pray that you will change all that portion of said above described highway which runs as follows:

Beginning at a point of the east line of Section 12, Town 28, Range 22, distant 1299.11 feet south of the $\frac{1}{4}$ corner on the east line of said Section 12,

And running thence S. $42^{\circ} 21'$ W. a distance of 180.88 feet to a point; thence S. $28^{\circ} 50'$ W. a distance of 386.82 feet to a point; thence S. $9^{\circ} 18'$ W. a distance of 77.72 feet to a point; thence S. $21^{\circ} 38'$ East a distance of 170.49 feet to a point; thence S. $9^{\circ} 00'$ E. a distance of 149.25 feet to a point; thence S. $36^{\circ} 44'$ E. a distance of 199.36 feet to a point; thence S. $24^{\circ} 38'$ E. a distance of 186.30 feet

And terminating at a point on the east line of said Section 12, Township 28, Range 22 and distant 214.4 feet north from the S.E. corner of said Section 12,

And now connected with other roads as follows: NONE

So that the same when changed will run as follows:

Beginning at a point on the East line of Section 12, Township 28, Range 22, and distant 1299.11 feet south of the $\frac{1}{4}$ corner on the east line of said Section 12,

And running thence south along the east line of said Section 12,

And terminating at a point on the east line of said Section 12, Township 28, Range 22, and distant 214.4 feet north from the southeast corner of said Section 12, Township 28, Range 22, and to be four (4) rods in width

And to be connected with other roads as follows: NONE
