



PETITION FOR ESTABLISHING COUNTY ROAD

TO THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF RAMSEY, MINNESOTA

The undersigned freeholders of the County of Ramsey hereby petition your Honorable Board for the establishment of a highway not within the limits of any incorporated city, and described as follows:

Beginning at the Northwest corner of the Southwest quarter of Section 18, Town 30, Range 23, and running thence east to the Northwest corner of the Northeast quarter of the Southwest quarter of the above said Section Number 18. Thence south to the Southwest corner of the Northeast quarter of the Southwest quarter of said Section 18, thence East to the Northwest corner of the South half of the Southeast quarter of said Section 18, and running thence South on the quarter Section line through Sections 18, 19 and 30, to the Northwest corner of the Northeast quarter of Section 31, Town 30, Range 23, thence East on the Section lines of Sections 30 and 31, 29 and 32, in said Town 30, Range 23, to the Northwest corner of the Northeast quarter, of the Northwest quarter of Section 32, Town 30, Range 23, thence running North 20 rods, thence East to the Road known as the Long Lake Road, all in the County of Ramsey and State of Minnesota.
