FINDINGS AND ORDER ESTABLISHING
A JUDICIAL ROAD

The above entitled proceedings being duly on the calendar of said Court came on for hearing on Friday, November 12,1948 before the undersigned one of the judges of said Court. Wyman Smith appeared for the Petitioners herein, and Robert G. Flynn appeared for the County of Ramsey, and no one appeared for any of the other parties interested.

From the files of said Court it appears that the Petition and Notice of Hearing were duly and properly served and posted and published. That the Commissioners appointed by the Court in accordance with the order herein made on the 10th day of September, 1948 have fully complied with said order and with the provisions of the statutes relating to the said proceedings. From the files herein and from the testimony adduced at said hearing, the Court

Finds and Determines

1. That the highway described as follows:

"A highway sixty-six (66) feet wide, running generally north and south between Trunk Highway #10 and south to the highway known as "Lakeview Drive", a distance of one-third of a mile more or less, and on the line dividing the said Counties of Anoka and Ramsey; said highway being thirty-three feet east of said County line in the County of Ramsey along said County line, all within the township of Mounds View and within Section 6, Township 30, Range 23 West, and also being thirty-three feet west of said County line in the County of Anoka along said County line, all within the township of Fridley and within Section 1, Township 30, and Range 24 West",

is a proper and necessary public improvement.

2. That said highway lies in the Counties of Ramsey and Anoka along the line dividing said counties and that one-half of said highway lies in each of said counties; and that the just proportion of the expense of establishing and improving said highway to be born by said Counties is one-half thereof by the County of Ramsey and one-half by the County of Anoka.

3. That the expenses incurred by the Petitioners and Commissioners herein are proper, being as follows:

4. That said highway should be established, opened, and made fit for public travel as soon as practicable.

It Is Therefore Ordered:

1. That the highway described as follows:

"A highway sixty-six (66) feet wide, running generally north and south between Trunk Highway #10 and south to the highway known as "Lakeview Drive", a distance of one-third of a mile, more or less, and on the line dividing the said Counties of Anoka and Ramsey; said highway being thirty-three feet east of said County line in the County of Ramsey along said County line; all within the township of Mounds View and within Section 6, Township 30, and Range 23 West, and also being thirty-three feet west of said County line in the County of Anoka along said County line, all within the township of Fridley and within Section 1, Township 30, and Range 24, West",

is hereby established as a public highway in the said Counties of Ramsey and Anoka.

- 2. That the report of said Commissioners on file herein be, and the same is, hereby approved and confirmed.
- 3. That the County Commissioners of said Counties of Ramsey and Anoka are hereby directed to open said highway and render the same fit for public travel at as early date as practicable and that the expenses of such operation be borne by said Counties in equal shares.
- 4. That said County of Ramsey and County of Anoka shall share equally the following expenses incurred in this proceeding:
