Also Reservoir Ave. also known as Broadway from the Easterly line of Minnesota Belt Line RR Right of Way to Lexington Ave., being the East and West Road through the Center of Sections 15, 16, and 17, Town 29, Range 23, be and the same is hereby constituted and declared a County Road, the same not being within the corporate limits of any city or town. (On motion by Commissioner Groos, seconded Carr, same was adopted by the following vote: Ayes: Carr, Gross, Leinen and Lind. Nays, None.

Whereas upon the petition in writing of six legal voters residing within one mile of the route hereinafter described for a public highway a copy of their petition having been first duly posted and due notice having been given, required by law. The Supervisors of said town fixed upon a time and place when and where they would meet to hear any reason for or against laying out the same and having caused written notice thereof to be posted up in three public places near the line of said road, ten days previous to the time of such meeting and having heard such as were offered for or against the laying out of said road and having personally examined the route proposed in said petition for a road on the 20th day of April, 1872, viz: Commencing at a point on the Como Road 50 rods east of SW. corner of section 17 ~~from thence north~~ 200 rods to the south line of John Walsh's farm, thence west 50 rods to the Hennepin County line and they being of the opinion that such laying out was necessary and proper and that the public interest would be promoted thereby, and having granted the prayer of said petitioners and determined to lay out said road so soon as practicable. We the supervisors of Rose Township did on the 22nd day of April, 1873, cause a survey thereof to be made by a competent surveyor who made report to us as follows:
