And Whereas, Upon receiving said petition we did within thirty days thereafter make out a notice and fix therein a time and place at which we would meet and decide upon such application to wit: on 9th day of April, at 9 o'clock in the forenoon at Town Hall causing copies of such notices to be posted in three public places in said Town and each property owner along said proposed road to be notified at least ten days previous to such meeting and having met at such time and place as above stated in said notice and being satisfied that the applicants had at least ten days previous to such meeting caused said notice of time and place of meeting to be given to all the owners of land through which such highway shall pass by serving the same personally or by copy left at the usual place of abode of each of said owners, proof of which was shown by affidavit, we proceeded to examine personally such highway, and then hear any and all reasons for or against the laying out of said road and being of the opinion that such laying out was necessary and proper and that the public interest would be promoted, we granted the prayer of said petitioners and decided to lay out said road, the description of which is as follows: viz:

It is hereby ordered and determined that a road be and the same is hereby laid out and established according to the description last aforesaid and it is declared to be a public highway four (4) rods wide.

Whereas, a part of the damages sustained by reason of the laying out said road has been ascertained by the agreement of the owners of the lands through which said road passes, with us, and a part of the owners of the said lands have in writing released all claims to damages; but not being able to agree with the owners of the following described lands, claiming damages by reason of said highway passing through, and the owners of some of the said lands being unknown, we have assessed the damages to each of such individual claimants with whom we could not agree, and awarded damages to the owners of such lands through which such highway passes as are unknown, at what we deemed just and right; taking into account and estimating the advantages and benefits the road will confer on the claimants and owners, as well as the disadvantages. We have assessed and awarded damages as follows:
