Whereas, upon the application, in writing, of W. G. Hendrickson A. Chemidlin, W. B. Aldrich, George Reichard, A. J. Proe, J. O. Proe, H. B Gibbs, Joshua Robertson, Lorenzo Hoyt, M. Gantzer, J. M. Newson, Theodore Ayd twelve legal voters, residing within one mile of the road hereinafter described for a public highway, a copy of their petition having been first duly posted up, as requested ⁱⁿ by law, we, the supervisors of said town, did on the 26th day of February A.D. 1859, personally examine the road proposed in said petition for a road, to-wit: Commencing at the Northwest corner of Northeast quarter of Section Twenty-two (22), thence West, following the Section line to Southwest corner of Southeast quarter of Section Sixteen (16), thence North through West half of Section Sixteen (16), Section Nine (9) and of Section Four (4), ending at or near North west corner of Northeast quarter of Section Four (4) and having fixed upon a time and place when and where we would meet, to hear any reasons for or against laying out the same and having caused written notices thereof to be posted up in three of the most public places in said town eight days previous to the time of said meeting, and having met at the time and place appointed for hearing such reasons, and having heard such as were offered for or against the laying out of said road, and being of opinion that such laying out is necessary and proper, and that the public interest will be promoted thereby, and having granted the prayer of said petitioners, and determined to lay out said road, we did on the 28th day of March A.D. 1859, cause a survey thereof to be made by a competent surveyor, who made report to us, it is therefore ordered and determined that a road be, and the same is hereby laid out and established according to said survey and the plat hereunto annexed and made part of this order, which is hereby declared to be a public highway, four rods wide, the line of said survey being the centre of said road.

In witness whereof, we, the said supervisors, have hereunto set our hands this 13th day of April A.D. 1859.

Commencing at the NW. corner of NE. quarter of section 22, thence west following the section line to NW. corner of SE. quarter section 16, thence north through west half of section 16, section 9 and of section 4 ending at or near NW. corner of NE. quarter section 4 and having fixed upon a time and place when and where we would meet to hear any reason for or against laying out the same and having caused written notice thereof to be posted up in three of the most public places in said town eight days previous to the time of said meeting and having met at the time and place appointed for hearing such reasons and having heard such as were affixed for or against the laying out of said road and being of opinion that such laying out is necessary and proper and that the public interest will be promoted thereby and having granted the prayer of said petitioners and determined to lay out said road, we did on the 28th day of March, 1899, cause a survey thereof to be made by a competent surveyor who made report to us, it is hereby ordered and determined that a road be and the same is hereby laid out and established according to said survey and the plat herunto annexed and made part of this order which is hereby declared to be a public highway four rods wide the line of said survey being the center of said road.
