ST. PAUL AND LITTLE CANADA TERRITORIAL ROAD

--ST. PAUL TO LITTLE CANADA--

That a Territorial Road shall be established from the Town of St. Paul to Little Canada, in the County of Ramsey, and that James R. Clewet, David Eberts and Benjamin Jarvis, are hereby appointed commissioners to locate said road, and said commissioners shall meet in the Town of St. Paul, on the first Monday in November next, or as soon as practicable thereafter, and proceed to the discharge of the duties herein assigned them.
