For Change Mounds View and Kettle River Road, Filed April 10th, 1911, Geo. J. Ries, County Auditor, by Ringwald, Deputy.

At a meeting of the Board of County Commissioners of said County, held April 3rd, 1911, a copy of the report of the committee appointed by us at our last session to examine the road hereinafter named, having been duly returned, by which said report it appears that the said committee met at the time and place designated in our order of appointment and examined the highway proposed to be changed, viz:

Beginning at the Manomin Road in Section 16, Township 30, Range 23 and running thence North and East through Sections 16, 9, 4, 3, 2 and 1, of Mounds View and Sections 6 and 5 of White Bear called the Mounds View and Kettle River road and terminating at the Centerville road; and do hereby recommend that the prayer of the said petitioners be granted.

And recommended that the prayer of the petitioners for the change of said highway be granted; and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the change of said highway and that the change of said road would be of sufficient advantage to the County to warrant the paying of the damages hereinafter assessed, we do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby changed according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which such highway is changed, that they cause so much of said highway as lies in their respective towns to be opened without delay.

We have assessed the damages sustained by reason of the change of said road to the lands over which the same passes and to the owners thereof, as follows:

M. Trojanowski, one hundred and fifty (\$150.00) dollars; John Dombrowski, sixty (\$60.00) dollars and Andrew Trojanowski fifteen (\$15.00) dollars, John Dombrowski, South 33 ft. of the NE. 1/4 of the NE. 1/4 of Section 3, Township 30, Range 23, M. Trojanowski, A strip 66 ft. wide commencing at a point on the center of old Kettle River and Mounds View Road, 752 ft. NW'ly. from a point 56.2 ft. North of 1/4 corner on East line of Section 3, Township 30, Range 23, thence in a NW'ly. direction to the 1/4 1/4 corner on the North line of the South 1/2 of the NE. corner of said Section 3, the North 33 ft. of the South 1/2 of the NE. 1/4 said Section 3, except the W'ly. 660 ft. thereof, Andrew Trojanowski, the W'ly. 660 ft. of SW. 1/4 of NE. 1/4 of 3-30-23. County takes North 33 feet.
