COUNTY OF RAMSEY) SS:

At a meeting of the Board of County Commissioners of said County, held Sept. 7th, 1886, a copy of the report of the Committee appointed by us at our last session to examine the road hereinafter named, having been duly returned, by which said report it appears that the said committee met at the time and place designated in our order of appointment and examined the highway proposed to be laid out, viz:

Beginning at a point on the section line between Sections Thirteen (13) and Fourteen (14) in Township Twenty-nine (29), North of Range Twenty-three where the Minneapolis, Lake Como and New Canada Road intersects the said section line and running thence Northerly on the said section line between Sections Fourteen (14) and Thirteen (13) and the section line between Sections Eleven (11) and Twelve (12) and the section line between Sections One and Two in said Township and Range to a point where the line between Lots Eleven (11) and Twelve (12) of A. K. Barnum's Garden Lots extended meets said section line, thence Northwesterly along said line between said Lots Eleven (11) and Twelve (12) of A. K. Barnum's Garden Lots to the shore of Lake Owasso, such road to be sixty-six (66) feet wide and to be located one-half ($\frac{1}{2}$) thereof on each side of said lines.

And recommended that the prayer of the petitioners for the location of said highway be granted; and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the opening of said highway and that the construction of said road would be of sufficient advantage to the County to warrant the paying of the damages hereafter assessed, we do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby located according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which said highway is located, and they cause so much of said highway as lies in their respective towns to be opened without delay.

We assessed the damages sustained by reason of the opening of said road to the lands over which the same passes and to the owners thereof, as follows:
