SUPERVISORS' ROAD ORDER

Whereas, Upon the petition in writing of six legal freeholders residing within one mile of the route hereinafter described for a public highway, a copy of their petition having been first duly posted as required by law. We the supervisors of said Town, did on the 13th day of November, 1869, personally examine the route proposed in said petition for a road, to-wit:

Commencing at the quarter post between sections 15 and 22 of Township 29, Range 23, thence due East along the South line of sections 15 and 14, thence Northwardly on the most practicable route to the Town Line between Rose and New Canada, and having before determined to lay out said road, fixed upon a time and place, when and where we would meet to hear any reasons for or against laying out the same.

And having caused written notices thereby to be posted up in three (3) public places near the line of said road, 10 days previous to the time of such meeting. And having met at the time and place appointed for hearing such reasons, and having heard such as were offered for or against the laying out of said road, and being of opinion that such laying out is necessary and proper and that public interest would be promoted thereby; and having granted the prayer of said petitioners and determined to lay out said road. We did on the 30th day of November, 1869 cause a survey to be made by a competent surveyor who made report to us as follows:

Beginning at the quarter post between Sections 15 and 22 marked "O", thence East 120 chains to corner of Sections 13, 14, 23 and 24, thence North 6.55 chains, thence North 540 West 3.10 chains North 420 West 1.75 chains North 120 W. 6.00 chains North 60 East 10.00 chains North 13.20 chains East 17.35 chains North 480 East 15.60 chains, North 300 East 38.45 chains North 680 East 28.80 chains, to New Canada and Rose Township line 11.80 chains North from corner of sections 7, 12, 13 and 18.

I hereby certify that the above diagram and field notes are correct in accordance with the survey.

It is therefore endorsed and determined that a road be, and the same is hereby laid out and established according to said survey and plat thereunto annexed and made part of this order, which is hereby declared to be a public highway four rods wide, the line of said survey being the center line of said road.
