COUNTY OF RAMSEY) SS:

At a meeting of the Board of County Commissioners of said County, held August 19, 1907, a copy of the report of the committee appointed by us at our last session to examine the road hereinafter named, having been duly returned, by which said report it appears that the said committee met at the time and place designated in our order of appointment and examined the highway proposed to be changed, viz: Beginning ---

The following petition was received and read to the Board:

The undersigned free-holders of the County of Ramsey petition your Honorable Board for the change of a highway, running into more than one town of said County, and not within the limits of any incorporated city, and described as follows:

Correction of Location of Barlow Road.

Examining the location of Barlow Road it was found that the connection with Barlow Road could be only at corner between sections 4, 5, 8 and 9 of township 30, range 23.

Beginning at the SE corner of section 3, township 29, range 23, thence due north on the section line, as near as practicable, to the NE corner of section 27, township 30, range 23, thence west on the section line, as near as practicable, to the SW corner of section 22, thence north on the section line, as near as practicable to the NE corner of section 21, thence west to the quarter post between sections 16 and 21, from thence north through the center of section 16 and 9 to section 4, from thence east, as near as practicable, on the section line between sections 4 and 9, 3 and 10, to the center of section 3, from thence to the quarter post between sections 2 and 3, thence to the Columbus Road in said township 30, range 23.

And your petitioners pray that you will change all that portion of said above described highway, which runs as follows:

Beginning at the quarter section corner on the east side of section 3, township 30, range 23, thence north-westerly and southwesterly through the south half of the NE quarter of said section 3, to the center thereof, thence southwesterly to a point, the quarter quarter section line running east and west through S.W. quarter of said section 3, thence west on the quarter quarter section line through S.W. quarter of said section 3, and the S.E. quarter of section 4, to a point on the north and south quarter section line of said section 4, thence south on said quarter section line to the quarter section corner between said section 4 and section 9, township 30, range 23, and now connected with other roads as follows:

Lexington Avenue at the quarter corner between sections 2 and 3, Hamline Avenue at center of section 3, town road at section line, between sections 3 and 4, and Kettle River and Mounds View road at quarter section corner between sections 4 and 9. So that the same when changed will run as follows:

Beginning at the section corner between sections 2, 3, 10 and 11, township 30, range 23, and running thence west on the section line between sections 3 and 10, 4 and 9, to the section corner between said sections 4 and 9, and sections 5 and 8. And to be connected with other roads as follows:

Lexington Avenue, also Turtle Lake road, at corner of sections 2, 3, 10 and 11; Hamline Avenue at quarter corner, between 3 and 10; town road at corner of sections 3, 4, 9 and 10; Kettle River and Mounds View road at quarter corner between sections 4 and 9, and Barlow Road at corner between sections 4, 5, 9 and 10, being an extension of the Turtle Lake road, two miles west.

And your petitioners pray that you will proceed to change said road and cause the same to be opened according to law. Dated at Mounds View this 10th day of June, 1907.

The Board deemed the petition reasonable on its face and appointed Monday, the 5th day of August, 1907, at 10 o'clock A.M. at the Court House and City Hall, St. Paul, as a date of hearing on said petition, and the Chair appointed Commissioner Bures, Fairchild, G. A. Nash, Louis Nash, Peter and Powers, members of said Board, a committee to examine said proposed change of said road; said committee to meet at the residence of N. P. Sjostedt, in said County on Friday the 2nd day of August, 1907, at 3 o'clock P.M. to examine said change and report its findings and recommendations to the Board.

And recommended that the prayer of the petitioners for the change of said highway be granted; and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the change of said highway and that the change of said road would be of sufficient advantage to the County.
