REMARKS:

DESIGNATING COUNTY ROAD

Aug. 17, 1935 In further consideration of the application of the Town Board of New Canada in regard to the County taking over the maintenance of certain highway dated July 2, and which had previously been referred by the Board to the County Surveyor for investigation and recommendation, County Surveyor Schulz reported that he had made a careful investigation of this proposition and his Department is willing to take up the maintenance of these roads, and so recommend to the County Board.

After a discussion of this request and also Mr. Schulz, Commissioner Swan moved, seconded by Commissioner Moeller that on and after January 1, 1936 that the following roads located in New Canada Township be designated as County Roads:

- 1. The East County Line from Highwood Ave. to Carver Avenue
- 2. Carver Ave. from the East County Line to the City Limits of St. Paul.
- 3. Cortland St. from County Road A-2 to Larpenteur Avenue.

Adopted by the following vote: Ayes - Moeller, Peter, Rohland, Schmidt, Swan and Gehan. Nays- Carr. Commis-10 sioner Carr explained his vote "No" by stating that he was opposed to the additional expense which the County would incur in maintaining these roads.
