Whereas, Upon the petition of six (6) legal voters owning real estate or occupying real estate under the Homestead or Pre-emption laws of the United States or under contract from the State of Minnesota within one (1) mile of the road proposed in said petition to be laid out, copies of said petition having been first duly relation thereto, proof of which posting was duly shown to us by affidavit, which said proposed new road is set forth and described in said petition as follows, viz:

Beginning at the 1/4 corners on the East side of Section twelve (12), Township twenty-nine (29), Range twenty-three (23) West and running thence West on the 1/4 line to the 1/4 corners on the West side of said Section twelve (12), thence West on the 1/4 line through Section eleven (11), to the 1/4 corners at the SW corner of the SE4 of the NE4 of Section eleven (11), Township twenty-nine (29), Range twenty-three (23) and whereas:

Upon receiving said petition we did, within thirty (30) days thereafter make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit:

On the 26th day of March 1886 at 2:00 o'clock P.M. at John Burket's house, causing copies of such notice to be posted up in three of the public places of said town at least ten (10) days previous to such meeting least ten (10) days previous to said time caused said notice and being satisfied the applicant had at the occupants of the land through which such highway might pass by serving the same personally or by copy left to examine personally such highway and being of the opinion that such laying out was necessary and proper and that the public interest would be promoted thereby we granted the prayer of said petitioners and determined to lay out said road, the description of which as so laid out is as follows:

Beginning at the 1/4 corner on the East side of Section twelve (12), Township twenty-nine (29), Range twenty-three (23) West, running thence West on the 1/4 line to the 1/4 cor. on the West side of Section twelve (12), thence West on the 1/4 line through Section eleven (11) to the 1/4 1/4 cors. of the SW corner of the SE 4 of Section eleven (11), Township twenty-nine (29) Range twenty-three (23).

It is Therefore Ordered and Determined that a road be and the same is hereby laid out and established according to the description last aforesaid and it is hereby declared to be a public highway four (4) rods wide, the said description above given being the center of said road.
