STATE OF MINNESOTA COUNTY OF RAMSEY

At a meeting of the Board of County Commissioners of said County, held December 3rd, 1906, a copy of the report of the committee appointed by us at our session August 20th, 1906 to examine the road hereinafter named, having been duly returned, by which said report it appears that the said committee met at the time and place designated in our order of appointment and examined the highway proposed to be changed, viz:

Beginning at a point on the southerly line of section four (4), township twenty-nine (29), range twenty-two (22), in the Town of New Canada, And running thence in a northeasterly, northerly and northwesterly direction through section four (4), township twenty-nine (29), range twenty-two (22), and Sections thirty-four (34), twentyseven (27), twenty-two (22), twenty-three (23), fourteen (14), eleven (11), and ten (10), And terminating at the northeast (N.E.) corner of section three (3), township (30), range twenty-two (22), and your petitioners pray that you will change all that portion of said above described highway which runs as follows:

Beginning at a point on the east line of section three (3), township thirty (30), range twenty-two (22), thirteen-hundred and fifty-one (1351) feet south of the northeast corner of said section, And running thence south on said east line of said section three (3), nine-hundred and forty (940) feet, thence south forty-five (45) degrees west along the center line of the road as now traveled six-hundred and seventy (670) feet to a point, And terminating at said point,

So that the same changed will run as follows:

Beginning at a point on the east line of section three (3), township thirty (30), range twenty-two (22),

thirteen hundred and eighteen (1318) feet, south of the northeast corner of said section,
And running thence sixty-seven (67) degrees west, west three-hundred and sixty-three (363) feet, thence south twenty-eight (28) degrees fifteen (15) minutes, west three-hundred and thirty-seven (337) feet, thence south four (4) degrees fifteen (15) minutes, east five-hundred (500) feet, thence south seven (7) degrees, fifteen (15) minutes. west five-hundred and eighty-one feet (581)

The names of the owners of the lands as far as known, through which the same now passes, are: Engelbreth H. Hobe, Evangeline Hobe, A. E. Bates,

And the names of the owners of the lands, as far as known, through which the same may pass when changed are: Engelbreth H. Hobe, A. E. Bates,

And recommended that the prayer of the petitioners for the change of said highway be granted; and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the change of said highway and that the change of said road would be of sufficient advantage to the County to warrant the paying of the damages hereinafter assessed, we do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby changed according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which such highway is changed, that they cause so much of said highway as lies in their respective towns to be opened without delay.
