County Commissioners' Road Order

At a meeting of the Board of County Commissioners of said County, held June 14, 1887, a copy of the report of the committee appointed by us at our last session to examine the road hereinafter named, having been duly returned, by which said report it appears that the said Committee met at the time and place designated in our order of appointment and examined the highway to be extended, viz:

Commencing on the shore of Bald Eagle Lake in the center of Lake Avenue (so-called) in the Town of Bald Eagle, where the above county road intersects said Lake Avenue, thence W'ly. along said Avenue and along the shore of Bald Eagle Lake to lot 1, Section 11, Township 20, Range 22.

Thence North 67° 5' West 446 ft., thence North 24° 20' West 700 feet,
Thence North 28° 10' West 800 ft., thence North 19° 28' West 1640 ft.,
Thence North 8° 27' East 980 ft., thence North 21° 23' West 500 ft.,
Thence North 9° 41' East 400 ft., thence North 13° 49' West 300 feet,
Thence North 24° 34' West 832 ft., thence North 28° 30' East 370 feet,
Thence North 54° 30' East 433 ft., thence North 21° 30' West 940 feet,
Thence North 49° West 340 ft., thence North 7° West 380 feet,
Thence North 36° East 284 ft., thence 50° East 840 feet,
Thence North 21° 30' East 225 ft.,

to the Ramsey County and Anoka County line, striking said line 90 feet East of section corner between sections 2 and 3, Township 30, Range 22, and do hereby recommend that the prayer of the petitioners for the extension of said highway be granted; and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the extension of said highway, and that the extension of said road would be of sufficient advantage to the County to warrant the paying of damages hereinafter assessed.

We do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby opened and extended according to the description above given which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the supervisors of the several towns, through such highway is extended, that they cause so much of said highway as lies in their respective towns to be opened without delay.
