COUNTY COMMISSIONERS' ROAD ORDER

August 2, 1875

Ayes - Blasdel, Brainerd, Lindeke, Kelly, Welch and Maxfield, 6 - Nays-Lee, 1 Filed Aug. 2nd, 1875 - S. Lee Davis, County Auditor

Whereas, upon the petition in writing of twenty-nine (29) legal voters, freeholders of the County of Ramsey, which was referred to us by the Board of County Commissioners of said County on the 13th day of March 1875, for a county road, a copy of their petition having been first duly posted as required by law in three (3) public places in said County, we, the committee on Roads and Bridges, Commissioners of Ramsey County, did on the 22nd day of June A.D. 1875 personally examine the route proposed in said petition for a county road as follows, to-wit:

Commencing at a point where the line between Sections thirty-two (32) and thirty-three (33) in Township twentynine (29). Range twenty-three (23) intersects the line of the St. Paul and St. Anthony Road, from thence North on the section line between Sections thirty-two (32) and thirty-three (33), twenty-eight (28) and twenty-nine (29), twenty (20) and twenty-one (21) or as near as practicable around marshes to the said section lines to intersect the county road running from Lake Como to Minneapolis, and having determined and fixed upon a time and place when and where we would meet to hear any reasons against the laying out of said county road, and none having been offered against the laying out of said road and being of opinion that such laying out is necessary and proper and that the public interest would be promoted thereby, and having granted the prayer of said petitioners and determined to lay out said road we did on the 6th day of July A.D. 1875, cause a survey thereof to be made by a competent surveyor who made report to us as follows:

To the Commissioners of the County of Ramsey and State of Minnesota:

The undersigned having been employed by you to make a survey for a road from a point where the line between Sections thirty-two (32) and thirty-three (33) of Township twenty-nine (29), Range twenty-three (23) intersects the center line of the old St. Paul and St. Anthony Road, thence northwardly to the corner of Sections 16, 17, 20 and 21; would report that the following is a correct survey thereof as made by me under your directions, to-wit:

Beginning at a point where the line between Sections thirty-two (32) and thirty-three (33) of Township twentynine (29), Range twenty-three (23) intersects the center line of the old St.Paul and St.Anthony. Thence North on section line 2210 feet to the center of University Ave. thence North 702 West along the center line of said avenue, 1525 feet to the West line of the NEt of the NEt of Section thirty-two (32), Thence North 2925 feet to the NW corner of the NEt of the SEt of Section twenty-nine (29), thence North 840 feet to a post, thence North 14 East, 1460 feet to a post, thence North $36\frac{1}{2}$ East 460 feet to a post on the line, Sections 20 and 29, 690 feet West of the corner of Sections 20, 21, 28 and 29, thence North 48 E., 920 feet to the line between Sections 20 and 21, thence North on Section line 2005 feet to the 1/4 post between Sections 20 and 21, thence North 2630 feet to the center of the old road and corner of Sections 16, 17, 20 and 21 of Township twenty-nine (29) and Range twenty-three (23) near Mr. Gibbs' residence, all in the Town of Rose, County of Ramsey and State of Minnesota, and that herewith is a correct plat of said road, according to said survey.
