SUPERVISORS' ROAD ORDER

REMARKS:

Vacation of private road
in Schifsky's Addition,
Sec. 11-30-23 West of Turtle
Lake.

On the 15th day of July 1933 at two o'clock in the afternoon of said day at the premises of Schifsky's Addition in said Mounds View Township, as the time and place designated by the Town Board and its supervisors, the said Board met and after due proof being given by affidavit of Carl L. Stutsman and affidavit of Andrew Hilger of personal service and posting of said notice at least ten days before said meeting for examining the road or cartway proposed to be altered and vacated, heard all the parties interested and after due consideration of the reasons advanced in favor of granting such petition and those in opposition thereafter said Board duly adjourned from time to time until the last adjourned meeting at the Town Hall of Mounds View Township, Ramsey County, Minnesota on the 28th day of October, 1933, at 3 o'clock P.M. and after being advised that the only person objecting to said petition, to-wit: Louis Schifsky, had withdrawn his objection thereto and had consented to the granting of said petition the Board of Supervisors in said Mounds View Township determined to grant said petition, and :

It is hereby ordered that the private road, path or cartway described as follows, to-wit:

That private path lying between Lot numbered five (5) and Lot six (6) in Schifsky Addition according to the maps and plat thereof on file of record in the office of the Register of Deeds in and for Ramsey County, be and the same is hereby vacated and the whole thereof.

It is further ordered that the portion of road and path described as follows:

Commencing at a point thirty-three feet east of the southwest corner of Government Lot two (2), Section eleven (11), Township thirty (30) north, Range twenty-three (23) west, Mounds View Township, thence east to the southwest corner of Lots numbered one (1), two (2), three (3), four (4), five (5), six (6), seven (7), eight (8), nine (9), ten (10) in Schifsky's Addition to the southwest corner of Lot number eleven (11), thence west 25.91 ft. thence south on a line parallel to and twenty-four ft. west on the westerly line of said Lots number one (1), two (2), three (3), four (4), five (5), six (6), seven (7), eight (8), nine (9), ten (10) to a point twenty-four feet north of the southern line of said Government Lot number two (2), then west on a direct line to the easterly line of the public road, being thirty-three feet east from the west boundary line of said Government lot number two (2), thence south to the place of beginning.

Be and the same is hereby vacated and the whole thereof.
