Whereas, upon the petition of thirteen (13) legal voters, who own real estate, or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within one mile of the road proposed in said petition to be altered, copies of said petition having been first duly posted up in three of the most public places of said Town, at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit; which said proposed alteration is set forth and described in said petition as follows, viz:

To change the Mounds View and White Bear Town Road as follows: Beginning at a point forty rods north of the southwest corner of the southeast quarter of Section one, Township thirty, Range twenty-three (23), Thence running north on the quarter section line to the northwest corner of the southeast quarter of section one, Township thirty, Range twenty-three (23), Thence running east on the quarter section line to the northeast corner of the southeast quarter of said section one, Township 30, Range 23.

And to also vacate that part of above named road that runs in a northeasterly and southwesterly direction through the southeast quarter of section one, Township 30, Range 23 and also that part that runs through the northeast quarter of Section one, the aforesaid new Road to be laid out four rods wide.

And Whereas, upon receiving said petition, we did, within thirty days thereafter, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: on the 20th day of March A. D. 1906, at the residence of N. P. Sjosdett causing copies of such notice to be posted in three public places in said Town at least ten days previous to such meeting; and having met at such time and place as above named in said notice, and being satisfied that the applicant had, at least ten days previous to said time, caused said notice of time and place of hearing to be given to all the occupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such highway, and heard any and all reasons for or against altering the same, and being of the opinion that such alteration was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners, and determined to----said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so laid out is as follows, to-wit:

Beginning at a point forty rods north of the southwest corner of southeast quarter of section one, Township thirty, Range twenty-three 23, thence running north on the quarter section line to the northwest corner of the southeast quarter of section one, Township thirty, Range twenty-three, thence running east on the quarter section line to the northeast corner of the southeast quarter of said section one, Township 30, Range 23.

It is Therefore Ordered and Determined that a road be, and the same is hereby altered and established according to the description last aforesaid, and the report and plat herewith accompanying, which is hereby made a part of this Order, and it is hereby declared to be a public highway 4 rods wide, the said description above given being the center of said road.
