Whereas, upon the petition of eight (8) legal voters, who own real estate, or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within one mile of the read proposed in said petition to be laid out, copies of said petition having been first duly posted up in three of the most public places of said Town, at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit; which said proposed road is set forth and described in said petition as follows, viz:

Commencing at said point in said Manomin road at the center of said section number fourteen (14) thence west along the south line of said lot number two (2) in said section number fourteen (14) eighty (80) rods more or less, to the southwest corner of said lot two (2). Thence north on the west line of said lot two to where said line intersects the Township road aforesaid laid out along the southerly and westerly shore of Turtle Lake the description of the lands over which the said new road passes and names of the owners thereof which are known as well as the lands the names of whose owners are unknown as follows: Vacated.

All that portion of the Township Road or highway laid out by the Supervisors of Mounds View Township, Ramsey County, Minnesota on or about 27th day of May 1885, said Township road being commonly known as the Turtle Lake Shore road beginning at a point in the road or highway known as the Manomin County road at the center of section number fourteen (14) Township number thirty (30) Range number twenty-three (23) Ramsey County, Minnesota and following said Township road as now laid out until it intersects.

And Whereas, upon receiving said petition, we did, within thirty days thereafter, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: On the first (1st) day of December, A.D. 1892, at the Town Hall in said previous to such meeting; and having met at such time and place as above named in said notice, and being satisfied that the applicant had, which such highway might pass. by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of same, and being of the opinion that such road was necessary and proper, and that the public interest would be promoted thereby, we granted herewith accompanying, the description of which as so laid out is as follows, to-wit:

Beginning new road asked for, the west line of lot number two (2) of said section fourteen (14) near the house of Henry Bucher, Senior, near the Shore of said Turtle Lake and to relay the same over the following described premises viz:

Commencing at said point in said Manomin road at the center of said section number fourteen (14) thence along the south line of said lot number two (2) in said section number fourteen (14) eighty (80) rods more or less to the southwest corner of said lot two (2) thence north on of Turtle Lake.

It is Therefore Ordered and Determined that a road be, and the same is hereby laid out and established according to the description last aforesaid, and the report and plat herewith accompanying, which is hereby made a part of this Order, and it is hereby declared to be a public highway four (4) rods wide, the said description above given being the center of said road.
