COUNTY COMMISSIONERS' ROAD ORDER

June 6, 1927

WHEREAS, A petition signed by twenty-four freeholders of said County, praying for the widening of a certain highway in said County, running in White Bear and Mounds View Townships of said county and not within the limits of an incorporated city, as hereinafter described, was presented to this Board at its session on the 26th day of July, 1926, and this Board having determined by the judgment of a majority of its members that said petition is reasonable on its face, and having by its order made at said session, appointed Tuesday, the 7th day of September, 1926, at 10:00 o'clock A. M. at C. H. and C. H. Building, St. Paul in said County, as the time and place for a hearing upon said petition, and having by said order appointed a committee of its members to examine said proposed widening of said road and designated Wednesday the 1st day of September, 1926, at 2:30 o'clock P. M. at intersection of County Road "E". and Lexington Avenue in said County, as the time and place for said committee to meet on the route of said proposed widened road, for the examination of the same, and having caused notices of said hearing and said meeting of said committee embodying a copy of said petition, to be posted in the three most public places of each town: through which said proposed widening of said road runs, or affected thereby, at least thirty days before the day of said hearing upon said petition, and being satisfied that said notices were so posted and proof of said posting duly made, and the said committee having met at the time and place designated in said order and said notices, and examined the same and made its report in writing to this Board, and recommended that said petition be granted, and said Board having met at the time and place designated in said order and said notices, to-wit: at C. H. and C. H. Building, St. Paul, in said County on Tuesday the 7th day of September, 1926, at 10:00 o'clock A. M., and duly heard all that anyone had to say in favor of, or against, the granting of said petition and considered said petition and the report of said Committee thereon, and a majority of said Board having agreed that said petition should be granted:

IT IS HEREBY ORDERED, That the prayer of said petition be and the same is hereby granted, and said highway is hereby widened covering that part of highway sought to be widened so as to run according to said Committee's report by courses and distances as follows, to-wit:

Beginning at a point 43 feet north and 33 feet west of NE. corner of Section 34, Township 30 North, Range 23 West, thence North 89°32' West, a distance of 4047.8 feet; thence South 0°28' West a distance of 43.0 feet; thence South 89°32' East a distance of 60.33 feet; thence South 0°28' West a distance of 43.0 feet; thence South 80°32' East a distance of 3733.37 feet; thence Southeasterly on a curve right (whose radius is 244.94 feet and central angle is 89°50') a distance of 384.04 feet; thence South 89°42' East a distance of 10 feet; thence North 0°18' East a distance of 330.1 feet to point of beginning.

(This final is an amendment to Final Order adopted by the County Board of Ramsey County, Minne sota, on the 7th day of September, 1926, and is for the purpose of correcting the description of the course of the highway shown, in petition and Final Order which was, through error and mistake, erroneously described, which description should read as shown in this amended Final Order.)
