DECLARATION.

Oct. 3, 1921

Resolved that the Town Road known as Lake Phalen Boulevard from Larpenteur Avenue running in a northwesterly direction along the shores of Lake Phalen to and connecting with the Keller Boulevard be and the same is hereby declared a County Road.

On motion of Keller, seconded Lind, same was adopted by the following vote: Ayes: Carr, Churchill, Farrell, Freeman, Keller, Lind and Hodgson. Nays: None

SUPERVISORS' ROAD ORDER

May 25, 1864

The petition of Carl Deilor, Carl Reuten, W. M. Stees and others for a road was granted and the order issued, to-wit:

It is hereby ordered and determined by the undersigned Supervisors of the Town of New Canada that the following described road with the accompanying description shall be and is declared to be a public highway, to-wit:

Commencing 53 rods S. from the centre of Section 16 and running thence S. 27 rods; thence S. 40 feet to Phalen Lake; thence S. 78° E. along the Lake Shore 200 feet
