Whereas, upon the petition of seven legal voters, who own real estate, or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within one mile of the road proposed in said petition to be vacated and copies of said petition having been first duly posted up in three of the most public places of said Town, at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit; which said proposed road to be vacated is set forth and described in said petition as follows, viz:

Beginning that certain street road on Highway known as Elm Street and situated on the west side of Block nine (9) of Gladstone also so much of Clarie Street in said Gladstone as is described as follows:

Commencing at the west line of the right of way of the St. Paul & Duluth R. R. Company as the same appears upon said plat thence Eastwardly to the point where said street intersects the west line of block ten (10) of said Gladstone also so much of Gladstone street in said Gladstone as is described as follows; that portion of said Gladstone street which is north of the north lines of the right of way of the St. Paul & St. Croix Falls R. R. Company as the same is shown upon the said plat of Gladstone, except that part of said street that is now not covered by the St. Paul Works Buildings.

And Whereas, upon receiving said petition, we did, within thirty days thereafter, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: on the 15th day of December A. It is Therefore Ordered and Determined that a road be, and the same is hereby vacated as described and established according to the descrition last aforesaid, and the report and plat herewith accompanying, which is hereby made a part of this order, and it is hereby declared to be a public highway---rods wide, the said description above given being the center of said road.
