Vacating a Road

Whereas, upon the petition of fifteen legal voters, who own real estate, or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within one mile of the road proposed in said petition to be vacated, copies of said petition having been first duly posted up in three of the most public places of said Town, at least twenty days before any and described in said petition as follows, viz:

Beginning at the southeast corner of block 9 of Gladstone, Ramsey County, Minnesota, according to the plat thereof on file and of record in the Office of Register of Deeds in and for said Ramsey County and including that portion of Gladstone street in said plat of Gladstone described as follows, viz:

The west 1/2 of said Gladstone street being a strip 30 ft. wide, running along the entire length of the East line of block 9, in the said plat of Gladstone north of the right of way of the St. Paul and St. Croix Falls R. R. Co., which includes the portion of said street vacated by your order dated December 20th, 1887.

And Whereas, upon receiving said petition, we did, within thirty days thereafter, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: On the 28th day of July A. D. 1890, at ten o'clock in the forencen causing time and place as above named in said notice, and being satisfied that the applicant had, at least ten days previous to said time, caused same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown by affidavit, we proceeded was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners, and determined which as so laid out is as follows, to-wit:

Beginning at the southeast corner of block 9 of Gladstone, Ramsey County, Minnesota, according to the plat thereof on file and of record in the Office of Register of Deeds in and for said Ramsey County and including that portion of Gladstone street in said plat of Gladstone described as follows, viz:

The west 1/2 of said Gladstone street being a strip 30 ft. wide running along the entire length of the east line of block 9 in the said plat of Gladstone North of the right of way of the St. Paul and St. Croix Falls R.R. Co. which include the portion of said street vacated by your order, December 20th, 1889.

It Is Therefore Ordered and Determined that a road be, and the same is hereby vacated and established according to the description last aforesaid, and the report and plat herewith accompanying, which is hereby made a part of this Order, and it is hereby declared to be a public highway 30 ft. wide, the said description above given being the center of said road.
