VACATION

of part of old Dale Street through the East 1/2 of NE 1/4 Sec. 14, T. 29, R. 23. COUNTY COMMISSIONERS' ROAD ORDER

November 4, 1889

At a meeting of the Board of County Commissioners of said County, held October 7th, 1889, a copy of the report of the committee appointed by us at our last session to examine the road hereinafter named, having been duly returned, by which said report it appears that the said committee met at the time and place designated in our order of appointment and examined the highway proposed to be vacated, viz:

Being situated in the Town of Rose in said County and in the East half on the Northeast quarter of said Section Fourteen (14), Township Twenty nine (29), N of Range Twenty-three (23), West of the fourth (4th) principal Meridian aforesaid, Commencing at a point on the highway which runs along the Section line running North and South between Sections Fourteen (14) and Thirteen (13) of said Township and Range; said highway being commonly known as Dale Street, at or near a point where the quarter section line running East and West through the center of said Section Fourteen (14) intersects said above described highway, thence running in a northwesterly direction through and across the east half of the Northeast quarter of said Section Fourteen (14) to a point where it intersects the road or highway which runs East and West along the north line of said Section 14.

And recommended that the prayer of the petitioners for the vacation of said highway be granted, and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the vacation of said highway and that the vacation of said road would be of sufficient advantage to the County to warrant the paying of the damages hereinafter assessed, we do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby vacated according to the description above given, which is hereby decreated to be vacated and no longer a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which such highway is vacated that they cause so much of said highway as lies in their respective towns to be vacated without delay.

We have assessed the damages sustained by reason of the vacation of said road to the lands over which the same passes and to the owners thereof, as follows:

To all owners over which the above described road passes, - Benefits - Nothing.

To all owners over which the above described road passes, Damages - Nothing.
