Whereas, upon the petition of nineteen legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within two (2) miles --- of the road proposed in said petition to be established; which said petition was filed with the Town in three of the most public places of said Town, at least twenty days before any action was had in relation thereto, said petition as follows, viz:

Beginning at a point on the west line of Section 13, Township 28, Range 22, where the same is intersected by the center of Highwood Avenue, being the quarter section corner on the west side of said section, running thence south on the section line between Sections 13 and 14, and between Sections 23 and 24 of said Township 28, Range 22 to the intersection of the center line of the Polander Road, so-called, Carver Avenue.

The above being a description of the center line of the proposed road and the total length to be 3/4 of a mile more or less.

And Whereas, Upon receiving said petition we did, within thirty days thereafter, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: on the 14th day of public places in said Town, at least ten days previous to such meeting; and having met at such time and place as caused said notice, and being satisfied that the applicant had, at least ten days previous to said time, highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such highway, and heard any and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to establish said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so ----- is as follows, to-wit:

Beginning at a point on the west line of Section 13, Township 28, Range 22, where the same is intersected by the center of Highwood Ave. being the quarter section corner on the west side of said section running thence south on the section line between Sections 13 and 14 and between Sections 23 and 24 of said Township 28, Range 22 to the intersection of the center line of the Polander Road, so-called, Carver Avenue.

The above being a description of the center line of the proposed road and the total length to be 3/4 of a mile more or less.

And it is Therefore Ordered and Determined, That a road be, and the same is hereby laid out and established according to the description last aforesaid, and the report and plat herewith accompanying, which is hereby given being the center of said road.
