SUPERVISORS' ROAD ORDER

STATE OF MINNESOTA)
COUNTY OF RAMSEY) SS
TOWN OF WHITE BEAR)

WHEREAS, upon the petition in writing of Andrew Erickson, John Asplund, John Stromberg, Jacob Mollitor, Basil Delonais, John B., Delonais, Alfred Charest, Gust Lundgren, eight legal voters, residing within three miles of the road hereinafter described, (the altering of which is prayed for in said Petition) a copy of their petition having been first duly posted, as required by law, we, the Supervisors of said town, did, on the 29th day of May A.D. 1903, personally examine the road proposed in said petition to be altered, to-wit:

Beginning at the Northwest corner of the Northeast quarter, N.E. 1/4, of the Northeast quarter, N.E. 1/4 of Section Six, 6, Town Thirty, 30, Range Twenty-two, 22, West. Thence running South a distance of thirty rods to intersection of present road and there terminating. Also further petition you to alter and discontinue that part of road beginning thirty rods South of the Northwest corner of the Northeast quarter, N.E. 1/4, of the Northeast quarter, N.E. 1/4, of said Section Six, 6, thence running Northeast to the Northeast corner of said Section Six, 6, and terminating there.

and having, before determining to alter said road, fixed upon a time and place when and where we would meet to hear any reasons for or against the altering of the same, and having caused written notices thereof to be posted up in three public places near the line of said road ten days previous to the time of such meeting, and having met at the time and place appointed for hearing such reasons, and having heard such as were offered, and being of the opinion that such altering of the said road is necessary and proper, and that the public interest would be promoted thereby, and having granted the prayer of said petitioners, and determined to alter the said road, we did, on the 29th day of May A.D. 1903, cause a survey thereof to be made by a competent surveyor, who made report to us, as follows, to-wit:

To the Supervisors of the Town of _____ in the County of _____ and State of Minnesota.

The undersigned having been employed by you to make a survey of a road beginning at _____

would report that the following is a correct survey thereof as made by me under your directions, to-wit:

It is, therefore, ordered and determined that the said road be and is hereby laid out and established according to said survey, and the plat hereunto annexed and made part of this order, which road is hereby declared to be a public highway four rods wide, the line of said survey being the center of said road.
