WHEREAS, upon the petition, in writing, of Ed. Vincent, Jos. H. Pivard, Charles Maranda, Frank Bibeau, Raphael Bibeau, Anthony Bibeau, Edmund D. Belland, Albert J. Peltier, R. J. Belland, and Edgar N. Belland, ten legal voters, residing within one mile of the road hereinafter described, (the vacation of which is prayed for in said Petition,) a copy of their petition having been first duly posted, as required by law, we, the Supervisors of said town, did, on the 22nd day of November, A. D. 1924, personally examine the road proposed to be vacated in said petition . to-wit:

Beginning at the northeast corner of lot #3, Section 32, Township 30, Range 22, thence running westerly and northwesterly along the shore of Vadnais Lake to the west line of section 32, and thence north along the west line of said section 32, and the west line of section 29, Township 30, Range 22 to a road traversing in an easterly direction from the northwest corner of the southwest quarter of the southwest quarter of section 29, Township 30, Range 22, along the north line of the south half of the southwest quarter of said section 29.

And having, before determining to vacate said road, fixed upon a time and place when and where we would meet to hear any reasons for or against the vacation of the same, and having caused written notices thereof to be posted up in three public places near the line of said road ten days previous to the time of such meeting, and having met at the time and place appointed for hearing such reasons, and having heard such as were offered, and being of the opinion that such vacation of the said road is necessary and proper, and that the public interest would be promoted thereby, and having granted the prayer of said petitioners, and determined to vacate the said road, we did, on the -----day of ----A. D. 18-- caused a survey thereof to be made by a competent surveyor, who made report to us as follows, to-wit:

To the Supervisors of the Town of ----in the County of ---- and State of Minnesota.

The undersigned having been employed by you to make a survey of a road beginning at----

Would report that the following is a correct survey thereof as made by me under your direction, to-wit:

It is, Therefore, Ordered and Determined that the said road be and is hereby laid out and established according to said survey, and the plat hereunto annexed and made part of this order, which road is hereby declared to be a public highway four rods wide, the line of said survey being the center of said road.
