Whereas, upon the petition of (Six) legal voters owning real estate within one mile of the road to be laid out proposed in said petition, copies of said petition having been first duly posted up in three of the most public places of said town at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit; which said proposed new road is set forth and described in said petition as follows, to-wit:

Beginning at a point where the present town road which runs from the Village of White Bear northwardly along the West side of the Saint Paul and Duluth Railroad intersects the County road which runs in front of the residence of Edward Long, thence running in a northerly direction up said West side of the Railroad, and parallel or nearly so with the same, to a point where said proposed new road will join with and run into Eagle Street as laid down in the surveyed and recorded plat of the Town of Bald Eagle, thence following said Eagle Street northward to its intersection with "Park Avenue" and thence eastwardly along said Park Avenue to its intersection when so extended with the Saint Paul and Duluth Railroad.

It is Therefore Ordered and Determined that a road be and the same is hereby laid out and established according to the description last aforesaid and the report and plat accompanying which is hereby made a part of this order, and it is hereby declared to be a public highway four rods wide, the said description above given being the center of said road.
