At a meeting of the Board of County Commissioners of said County held November 11th, 1884, a copy of the report of the committee appointed by us at our land session to examine the road hereinafter named having been duly returned, by which said report, it appears that the said committee met on October 25th, 1884 at August Richter's house and examined the highway proposed to be located, viz:

Beginning at the center of Section twenty-seven (27) and running South 2640.0 to 1/4 corner South side of Section twenty-seven (27) Thence South 2640.0 to center of Section thirty-four (34) thence South 1320.0 to 1/4 1/4 post; thence South 51°04' West 940.0; thence South 11°40' East 721.25, thence South 36° East 977.95; thence South 2024.85 to the center of Section three (3). And recommended that the prayer of the petitioners for the location of said highway be granted and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the locating of said highway, and that the locating of said road would be of sufficient advantage to the county to warrant the payment of the damages hereinafter assessed, we do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby located, according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the supervisors of the several towns through which such highway is located that they cause so much of said highway as lies in their respective towns to be opened without delay. We have assessed the damages sustained by reason of the location of said road to the land over which the same passes and to the owners thereof as follows;
