Whereas, a petition signed by twenty-four freeholders of said County, praying for the change of a certain highway in said County, running into more than one town, and not within the limits of any incorporated city, as hereinafter described, was presented to this Board at its session on the 3rd day of June, 1912, and this Board having determined by the judgment of a majority of its members that said petition is reasonable on its face, and having by its order made at said session appointed Monday the 15th day of July, 1912, at 10 o'clock A.M. at C.H. & C.H. in said County, as the time and place for a hearing upon said petition, and having by said order appointed a committee of its members to examine said proposed change of said road and designated Thursday, the 11th day of July 1912, at 3 o'clock P.M. at St. John's Church in said County, as the time and place for said Committee to meet on the route of said Labore Road for the examination of the same, and having caused notices of said hearing and said meeting of said Committee embodying a copy of said petition, to be posted in the three most public places of each town through which said proposed change of said road runs, or affected thereby, at least thirty days before the day of said hearing upon said petition, and being satisfied that said notices were so posted and proof of said posting duly made, and the said Committee having met at the time and place designated in said order and said notices, and examined the same and made its report in writing to this Board, and recommended that said petition be granted, and said Board having met at the time and place designated in said order and said notices, to-wit: at St. John's Church in said County on Monday the 11th day of July, 1912, at 3 o'clock P.M. and duly heard all that anyone had to say in favor of, or against, the granting of said petition, and considered said petition and the report of said committee thereon, and a majority of said Board having agreed that said petition should be granted,

It Is Hereby Ordered, that the prayer of said petition be and the same is hereby granted, and said highway is hereby ordered changed so as to run according to said committee's report, by courses and distances as follows, to-wit:

Commencing at a point in the center of the Labore Road on the South line of Section 5, Twp. 29, Rge 22, thence South $42^{\circ}31'$ East a distance of 25.65 feet to the place of beginning; thence North $86^{\circ}27'$ East a distance of 175.43 feet; thence North $87^{\circ}12'$ East a distance of 303.78 feet and terminating at a point in the center line of the present travelled Labore Road on the South side of Section 5, Twp. 29, Rge 22, and now connected with other roads as follows: McMenemy Street, so that when changed will run as follows:

Commencing at a point in the center of the Labore Road on the South line of Section 5, Twp. 29, Rge 22, thence South $42^{\circ}31'$ East a distance of 25.65 feet to place of beginning and running thence South $42^{\circ}31'$ East a distance of 220.17 feet; thence North $60^{\circ}39'$ East a distance of 378.50 feet and terminating at a point in the center of the present travelled Labore Road on South line of Sec. 5, Twp. 29, Rge 22 and to be four (4) rods in width and to be connected with other roads as follows: McMenemy Street.

It is Further Ordered, That the County Auditor notify the Town Supervisors of each town through which said road is changed of the fact of said change and that they shall cause to be opened so much of said highway as lies in their respective towns.

And Whereas, At the said hearing, upon said petition and said report of said Committee, certain persons over whose lands said proposed change of said road will pass, etc.etc. (not filled in nor damages assessed)
