## COUNTY COMMISSIONERS' ROAD ORDER

Project File #403

January 6, 1903

WHEREAS, the committee heretofore appointed by this board to examine and view the proposed change of Lexington Avenue Road, as prayed in the petition of Sarah E. Mills, et als, where the said road crosses the Northern Pacific Railroad right-of-way, and having reported in favor of granting said petition by their report, dated December 19, 1902, and the said report having been duly considered, and this board having heard all that might be said in favor of and against the granting of said petition, and having duly considered and determined the prayer of said petition, and William Gould, Sr., William Gould, Jr., Mary Gould, Jennie Gould and R. L. Gould, the persons over whose land the road will pass, having remonstrated against the prayer of the petition, setting forth in writing that they are damaged in the sum of five hundred dollars by the location, change and vacation of such highway, to the truth of which they have taken and subscribed their oath, and this board having determined from the face of the report of said committee and the evidence before them, that they, the said William Gould, Sr., William Gould, Jr., Mary Gould, Jennie Gould and R. L. Gould, are, and will be damaged in the said sum of five hundred dollars by reason of the location, change and vacation of said highway, and which damages are hereby assessed at said sum of five hundred dollars, and that this board deems the change and vacation of said road of sufficient advantage to the county to warrant the paying of the damages, so assessed, do hereby declare such highway vacated and changed, as prayed in said petition and direct that all damages assessed shall be paid by the said county of Ramsey.

BE IT RESOLVED by the Board of County Commissioners of Ramsey County, that the said petition for the vacation and change of that part of Lexington Avenue Road in said petition described be, and the same hereby is granted, and the County Auditor is hereby directed to notify the Supervisors of the several towns affected thereby of such change in vacation.

That part of said road hereby changed and vacated is described as follows:

That portion of the roadway which runs northerly through the north half (N.  $\frac{1}{2}$ ) of the northeast quarter (NE.  $\frac{1}{4}$ ) of Section 10 and the southeast quarter (SE.  $\frac{1}{4}$ ) of section 2, Township 29, Range 23, so that the same, when changed and vacated shall run and be located as follows:

beginning at a point on the section line between sections 10 and 11, Township 29, Range 23, 1518 feet north of the quarter section corner between said sections; thence north on the section line between said sections 10 and 11 and 2 and 3, Township 29, Range 23 to the intersection of the present traveled road.

Adopted by the following vote: Ayes: Gray, Nash, Pottgieser, Powers, Serrg, Wright and Chairman Smith, Nays: None.

On motion, the meeting adjourned.
