SUPERVISORS' ROAD ORDER

August 18, 1873

Whereas, upon the petition in writing of six legal voters residing within one mile of the route hereinafter described for a public highway, a copy of their petition having been first duly posted and due notice having
been given by petitioner to occupants of the land through which said highway would pass, as required by law, we, the
Supervisors of said Town, fixed upon a time and place when and where we would meet to hear any reasons for or against
laying out the same, and having caused written notices thereof to be posted up in three public places near the line
of said road, ten days previous to the time of such meeting, and having heard such as were offered for or against
the laying out of said road and having personally examined the route proposed in said petition for a road on the
31st day of July, 1873, viz:

Commencing at the Southeast corner of Section 10 in said Town and running thence due West between Sections 10-15-9-16-8 and 17 to the West line of Ramsey County and being of the opinion that such laying out is necessary and proper and that the public interests would be promoted thereby and having granted the prayer of said petitioners and determined to lay out said road, we did on the 18th day of August A.D. 1873, cause a survey thereof to be made by a competent surveyor who made report to us as follows:

"The undersigned, having been employed to make a survey of a road commencing at the S.E. Cor. of Section 10 in the Town of Rose, thence running due West between Sections 10-15-9-16-8-17 to the West line of Ramsey County would report that the following is a correct survey thereof as made by me under your directions, to-wit:

Beginning at the S.E. Corner Section 10 thence West var. 11 3/4° East 79.87 chains to the Corner of Sections 9-10-15-16, thence West var. $11\frac{1}{4}$ ° East 79.90 chains to Corner Sections 8-9-16-17, thence West var. $10\frac{1}{4}$ ° East 39.97 chains to $\frac{1}{4}$ Post, thence West var. $11\frac{1}{4}$ ° East 39.94 chains to the West line of Ramsey County and that herewith is a correct plat of said road according to survey."

It is therefore endorsed and determined that a road be and the same is hereby laid out and established according to said survey and plat thereunto annexed and made part of this Order, which is hereby declared to be a public highway, four rods wide, the line of said survey being the centre of said road.
