SUPERVISORS' ROAD ORDER

Whereas, upon the petition of Eleven (11) legal voters residing or owning real estate within one mile of the road proposed in said petition to be laid out, copies of said petition having been first duly posted up in three of the most public places of said town at least twenty days before any action was had in relation thereto, which said proposed new road is set forth and described in said petition as follows, viz:

Commencing on the North line of Rose Town where said line intersects the Minneapolis and White Bear Lake Road, run due South on the half section line through Sections Five (5), Eight (8) and Seventeen (17) to the Minneapolis and Como Road, and

Whereas, upon receiving said petition we did, within thirty days, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: on the Twenty-third (23) day of October A.D. 1876 at 10 A.M. at the house of Gotlieb Gluck on Section 5 in said Town, causing copies of such notice to be posted in three public places in said Town at least ten days previous to such meeting and having met at such time and place as above named in said notice and being satisfied that the applicant had at least ten days previous to said time caused said notice of time and place of hearing to be given to all occupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such highway, and heard any and all reasons for or against laying out the same, and being of the opinion that such laying out was necessary and proper and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out said road, the description of which is as follows, to-wit:

Beginning on the North line of Rose Town where said line intersects the Minneapolis and White Bear Lake Road, run due South on the half Section line through Sections Five (5), Eight (8) and Seventeen (17) to the Minneapolis and Como Road.

It is Therefore Ordered and Determined that a road be and the same is hereby laid out and established according to the description aforesaid and it is hereby declared to be a public highway four (4) rods wide, the description above given being the centre of said road.

Given under our hands this Seventh day of November A.D. 1876.
