At a meeting of the Board of County Commissioners of said County, held September 5th, 1876, the report of the committee appointed by us at and examined the highway proposed to be located viz:

Beginning at the quarter post between sections 15 and 22, Township 30, Range 23, Town of Mounds View, at the old Manomin Road, thence west on the section line on said Manomin Road to the corner of Section 15 and 16, 21 and 22, of said Town and Range; thence west on Section east on section line between sections 4 and 9, 3 and 10 from thence to the center of section 3 thence to the quarter post between sections 2 & 12 to the center of the Columbia Road in Mounds View Township, Ramsey County, to be known as the extension of the St. Paul, Lake Josephine and Mounds View Road and recommended that the prayer of the petitioners for said highway be granted;

It is Therefore Ordered and Determined that the prayer of said petition be granted; and that a highway be and is hereby located according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors without delay.
