Resolved, That the road in New Canada Township, commencing at the 1/4 1/4 corner of the S.W. 1/4 of the S.W. 1/4 of Section fourteen (14), Township twenty-nine (29), Range twenty-two (22); thence running in a NE'ly direction to the center of Section fourteen (14) where it intersects with the road known as East 7th Street of North St. Paul. Said road to be known as East Seventh. The same to be and is hereby accepted and adopted as a County Road from this date.
