The petition for the establishment of the county road hereinafter described came on to be heard by the County Board of said county on the 6th day of June, 1932 at 10:00 o'clock A.M. at the Court House and City Hall in the City of St.Paul in said county; and said Board having considered said petition and heard all parties interested as to the necessity for, and as to the amounts of damages to land owners by reason of such establishment of such road as described in said petition. finds as follows:

That at least twenty (20) days before the said time so fixed for the meeting of said committee and not less than thirty (30) days before said time of hearing on said petition said Board caused posted notices of the time and place of said meeting of said committee and of said hearing to be given in each town affected by said establishment of said road, setting forth in such notice a copy of said petition; and that proof of said notice and of the posting thereof has been made by affidavit of the person posting the same, to the satisfaction of said Board which notice and affidavits of posting are on file in the office of said County Auditor and are referred to as a part hereof:

That at the time and place designated in said order said committee did meet and examine the said route of said road proposed in said petition.
