COUNTY COMMISSIONERS' ROAD ORDER

At a meeting of the Board of County Commissioners of said County held February 6, 1889, a copy of the report of the committee appointed by us, to examine the road hereinafter named, having been duly returned, by which said report it appears that the said committee met at the time and place designated in our order of appointment and examined the highway proposed to be continued viz:

Beginning from Mounds View Township southerly on the quarter section line in Section 4, Township 29, Range 23, commencing (four rods wide) at the aforesaid County Road about ten rods north of the quarter section post of section 4 and 9, thence running due South on quarter section line to quarter section post of section 9 and 16 and to intersect with the County Road running East to Snelling Avenue.

And recommended that the prayer of the petitioners for the continuation of said highway be granted; and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the continuation of said highway and that the continuation of said road would be of sufficient advantage to the County, we do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby opened according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which such highway is opened, that they cause so much of said highway as lies in their respective towns to be opened without delay.

We have assessed the damages sustained by reason of the opening and continuation of said road to the lands over which the same passes to be equal to the benefits thereof.

REMARKS:

SUPERVISORS' ROAD ORDER

Whereas upon the petition of six legal voters residing or owning real estate within one mile of the road proposed in said petition to be laid out, copies of said petition having been duly posted up in three of the most public places of said Town at least 20 days before any action was had in relation thereto; which said proposed new road is set forth and described in said petition as follows, viz:

Beginning at the 1/4 section post of sections 16 and 9 thence running due North to Mounds View Town line of said 1/4 section line, or to intersect with the County Road, if there is any on said 1/4 section line, and whereas upon receiving said petition we did within 30 days make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: On the 23rd day of February, 1876 at 10 o'clock A. M. at the house of August Giesman on Section 9 in said Town causing copies of such notice to be posted in 3 public places in said Town at least 10 days previous to such meetings and having met at such time and place as above named in said notice and being satisfied that the application had at least 10 days previous to said time, caused said notice of time and place of hearing to be given to all the occupants of the land through which such highway might pass by serving the same personally or by copy left at the usual place of abode of each of said occupants proof of which was shown by affidavit, we proceeded to examine personally such highway and heard any and all reasons for or against laying out the same and being of the opinion that such laying out was necessary and proper and that the public interest would be promoted thereby we granted the prayer of the petitioners and determined to lay out said road, the description of which is as follows, to-wit:

Beginning at the 1/4 post between sections 16 and 9 of Township 29, Range 23, Rose Township, thence North on center line of said section 9, 80 chs. and 50 links to the 1/4 post between said section 9 and section 4, thence North on the center line of said section 4, 8 chs. and 50 links, connecting with the County Road leading from St. Paul to Anoka.

It is therefore ordered and determined that a road be and the same is hereby laid out and established according to the description aforesaid and the report and plat accompanying which is hereby made a part of their order, and it is hereby declared to be a public highway four rods wide, the description above given being the center of said road.
